**WHEREAS**, the Philippine Economic Zone Authority (PEZA) approved the bidding for the "Supply and Delivery of Seven (7) Units of Kilowatt-Hour Meters at PEZA-BCEZ", with an ABC of P420,000.00;

**WHEREAS**, on December 28, 2012, the Baguio City Economic Zone (BCEZ) – Bids and Awards Committee (BAC) advertised an Invitation to Bid at the PEZA website, the PhilGEPS and posted a copy thereof in conspicuous place/s at the premises of the PEZA-BCEZ continuously for seven (7) days consistent with Rule VII, Section 21.2.1.(c) of the Revised IRR, RA 9184;

**WHEREAS**, the Bid Opening is scheduled on January 16, 2013 at 2:30pm at PEZA-BCEZ Administration Building;

**WHEREAS**, on January 14, 2013, the end-user (Transco – BCEZ) had just provided the additional documents for the technical specifications after the Bidding Documents had been posted at the PhilGEPS particularly on the Communicator (Attachment A) and Ethernet Converter (Attachment B).


**WHEREAS**, Section 22.5.2. of the Implementing Rules and Regulation of R.A. 9184, entitled Supplemental/Bid Bulletins provides as follows: *"Supplemental/Bid Bulletins may be issued upon the procuring entity's initiative for purposes of clarifying or modifying any provision of the Bidding Documents at least seven (7) calendar days before the deadline for the submission and receipt of bids. Any modification to the Bidding documents shall be identified as an amendment."* (Italics supplied for emphasis.)

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

1. To reschedule the date of the Bid Opening for the "Supply and Delivery of Seven (7) Units of Kilowatt-Hour Meters at PEZA-BCEZ" from January 16, 2013 to January 23, 2013 at 2:30pm;
2. The technical specifications mentioned, to wit: Communicator (Attachment A) and Ethernet Converter (Attachment B) are hereby included in the Bidding Documents for the "Supply and Delivery of Seven (7) Units of Kilowatt-Hour Meters at PEZA-BCEZ";
3. Complete set of Bidding Documents may be purchased by interested bidders until January 23, 2013 not later than 10:00am, and deadline for submission of Bidding Documents will be January 23, 2013 at 2:00pm at the BCEZ Administration Building, Baguio City Economic Zone.
