

INVITATION TO BID

CONSTRUCTION OF ADDITIONAL WATERLINE CONNECTION FROM MAYNILAD TO DEEPWELL NO.4

(PEZA-CEZ 12-05-015)

1. The PHILIPPINE ECONOMIC ZONE AUTHORITY-CAVITE ECONOMIC ZONE (PEZA-CEZ), through its Corporate Operating Budget for CY 2012 intends to apply the sum of **PhP4,652,407.79** being the Approved Budget for the Contract (ABC) to payments under the contract for the Construction of Additional Waterline Connection from Maynilad to Deepwell No. 4. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PEZA-CEZ now invites bids for the Construction of Additional Waterline Connection from Maynilad to Deepwell No. 4. Completion of the Works is required within one hundred ninety six (196) calendar days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from PEZA-CEZ BAC Secretariat and inspect the Bidding Documents at the address given below from during Monday to Friday from 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be purchased by interested Bidders starting May 30, 2012 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Two Thousand Pesos Only (PhP2,000.00).
6. It may also be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of PEZA-CEZ,

provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

7. The PEZA-CEZ will hold a Pre-Bid Conference on June 07, 2012, 2:30 p.m. at 2nd Floor, Function Room, New Administration Building, Cavite Economic Zone, Rosario, Cavite, which shall be open only to all interested parties who have purchased the Bidding Documents.

8. Bids must be delivered on or before June 21, 2012, 2:00 p.m. at 1st Floor, BAC Secretariat, New Administration Building, Cavite Economic Zone, Rosario, Cavite. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18. Bids submitted beyond 2:00 p.m. will be disqualified to join the bidding process.

9. Bid opening shall be on June 21, 2012, 2:30 p.m. at 2nd Floor, Function Room, New Administration Building, Cavite Economic Zone, Rosario, Cavite. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

10. In any case of the above dates is declared a special non-working holiday, it will automatically be reset on the next working day.

11. The PEZA-CEZ reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
