



## INVITATION TO BID FOR THE SUPPLY AND DELIVERY OF TWENTY FIVE (25) UNITS BRANDED DESKTOP COMPUTERS WITH UPS FOR MACTAN ECONOMIC ZONE (RE-BIDDING)

1. The **Philippine Economic Zone Authority (PEZA)** through the Corporate Operating Budget 2013 intends to apply the sum of **Php 1,500,000.00** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply and Delivery of Twenty Five (25) Units Branded Desktop Computers with UPS for Mactan Economic Zone**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **PEZA** now invites bids for **Supply and Delivery of Twenty Five (25) Units Branded Desktop Computers with UPS for Mactan Economic Zone**. Delivery of the Goods is required within forty five (45) days from the receipt of the Notice to Proceed. Bidders should have completed, within one (1) year from the date of submission and receipt of bids, a contract similar to the Project equivalent to at least fifty percent (50%) of the BAC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".  
  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from **PEZA** and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 PM; Monday to Friday.  
  
A complete set of Bidding Documents may be purchased by interested Bidders on **28 February 2013** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Php 1,000.00**.  
  
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.
5. The **PEZA** will hold a Pre-Bid Conference on **10 April 2013; 2:00 PM** at **Conference Room, 2/f PEZA Administration Building, Mactan Economic Zone, Lapulapu City**, which shall be open only to all interested parties who have purchased the Bidding Documents.
6. Bids must be delivered to the address below on or before **22 April 2013; 2:00 PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause **Error! Reference source not found.**  
  
Bid opening shall be on **22 April 2013; 2:00 PM** at **Conference Room, 2/f PEZA Administration Building, Mactan Economic Zone, Lapulapu City**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
7. If any of the above date is declared a special non-working holiday, the schedule will automatically be reset on the next working day.
8. The **PEZA** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
