## B. Response to queries/clarifications

On Storage Support M.2SS up to 2 Tera: Can we remove the indicated "2280" or "2240" at the specs?	Per end user unit, the M.2 slot specification needs to be identified so that we can determine the storage capacity compatibility of the slot.
On Internet Extension Connector: Will be okay to have a built in?	Per end user unit, bidder's proposal may have ether a micro Ethernet connector with Ethernet extension adapter or built-in Ethernet port.
Physical Lock: Can this be made like a security lock slot and regardless if it's a Kensington cut or not as long as it has a lock slot?	Per end user unit, Kensington is not proprietary to any laptop manufacturer and it is carried by different brands of equipment. We will retain this spec to assure that the product being offered will be compatible with a quality security device.
Does the 14 slots desktop and storage support 2 slots?	Per end user unit, it is confirmed that the specification Storage Support has 2x2.5" HDD Slots

Executive laptops: Will you allow a 15.6 LCD Display? Parallel with that would it be okay that the case will increase including the weight and size for about 4 lbs?

Per end user unit, since the purpose of the Executive Laptop is to have a lightweight and compact machine for our PEZA Officers, we will stick with the original stated specifications.

Laptop keyboard: Can this be simplified to a "backlit spill-resistant keyboard" since current specs point out to a specific brand.

Per end user unit, we use our equipment beyond the industry standard of 3-years life cycle. So, having additional inputs like a builtin pointing device will be advantageous in the event of the touchpad malfunctioning.

#### Letter Inquiry:

As per checking your specifications, its pertaining in one brand & one model. And that brand has only one fulfiller only (bidder) who can give with their full support. For us to make it more competitive, let us open the specification to other brands, but there are some specs that is not comply on your requirements. Also, since you are requiring a lighter weight base on the specified weight, i/o ports are more limited, & some ports are already not available. Thus, giving you below the options to make it open to other brands: Option 1: Can we omit the 1 – USB-C 3.1 Gen 1 coz our first option has only one USB-C port Gen 2 with 1 – microSD card reader

Per end user unit, Omitting and/or relaxing our specifications will mean lowering and compromising our requirement. The equipment will have different deployments throughout the Agency and we come up with technical specifications that can cater to most of our end-user's needs. Lowering the specs will also be at a disadvantage to the Agency. If there exist in the market that can offer better specifications versus the budget we set, then that will be the minimum we will require.

Option 2: Can we omit the 1 – microSD card reader, since this is not necessary in our daily work load and our second option has no microSD card reader but with 2 – thunderbolt 4 (USB-Type C).

As per checking your specifications, its pertaining in one brand & one model. And that brand has only one fulfiller only (bidder) who can give with their full support. For us to make it more competitive, let us open the specification to other brands, but there are some specs that is not comply on your requirements.

May we request to relax it to 1 - USB 3.2 (side), our offered model has only 4 - USB 3.2 (rear) & 1 - USB 3.2 (side).

Per end user unit, Omitting and/or relaxing our specifications will mean lowering and compromising our requirement. The equipment will have different deployments throughout the Agency and we come up with technical specifications that can cater to most of our end-user's needs. Lowering the specs will also be at a disadvantage to the Agency. If there exist in the market that can offer better specifications versus the budget we set, then that will be the minimum we will require.
