

## **Invitation to Bid for Asphalt Overlay Project at MEZ**

## PEZA MEZ 2021-002

- 1. The **Philippine Economic Zone Authority**, through the Corporate budget for the Year 2021 intends to apply the sum of Nine Million Seven Hundred Thirty Five Thousand Eight Hundred Twenty Three Pesos and 71/100 (Php 9,735,823.71) being the Approved Budget for the Contract (ABC) to payments under the contract for project, **Asphalt Overlay Project at MEZ**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The **Philippine Economic Zone Authority** now invites bids for the above Procurement Project. Completion of the Works is required within 60 days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information **Philippine Economic Zone Authority** and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on 15 January 2021 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 10,000.00.The Procuring Entity shall allow the bidder to present in person its proof of payment for the fees.
- 6. The **Philippine Economic Zone Authority** will hold a Pre-Bid Conference<sup>1</sup> on **28 January 2021**, **2:00PM** at PEZA Office, AAI Building, Mactan Economic Zone, Lapu-lapu City and through videoconferencing, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before **10 February 2021; 2:00pm**. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.

- 9. Bid opening shall be on **10 February 2021, 2:00PM** at the PEZA Office, AAI Building, Mactan Economic Zone, Lapu-lapu City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **Philippine Economic Zone** Authority reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
