- 9. Bid opening shall be on **December 21, 2016, 10:00 AM** at 3F Conference Room, BCEZ Admin. Bldg. Baguio City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
