### **SUPPLY AND DELIVERY OF RACKMOUNT SERVERS (LOT 1) AND NETWORK ACCESS CONTROL (LOT 2) (PEZA-HO-2018-06)**

1. The Philippine Economic Zone Authority (PEZA), through its Corporate Operating Budget for CY 2017 intends to apply the following sum:

a) Lot 1 – Rackmount Servers	PhP	3,621,000.00
b) Lot 2 – Network Access Control (NAC)	PhP	3,400,000.00

The above amounts are the Approved Budget for the Contracts (ABCs). Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PEZA now invites bids for the supply and delivery of three (3) units rackmount servers (Lot 1) and two (2) units network access control (Lot 2). Delivery of the Goods is required within sixty (60) calendar days for Lot 1 and seventy-five (75) calendar days for Lot 2. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from PEZA and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders on 23 February 2018 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos Only (₱5,000.00) per lot.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The PEZA will hold a Pre-Bid Conference on 05 March 2018 at the PEZA Training Room, 3<sup>rd</sup> Floor PNOB Building 3, Energy Center, Rizal Drive, Bonifacio Global City, Taguig.
7. Bids must be duly received by the BAC Secretariat at the address below on or before 11:00 a.m. 19 March 2018. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**  
  
Bid opening shall be on 19 March 2018, 2:00 p.m. at the PEZA Training Room, 3<sup>rd</sup> Floor PNOB Building 3, Energy Center, Rizal Drive, Bonifacio Global City, Taguig. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. In case any of the above dates is declared as a special non-working holiday, it shall automatically be moved to the next working day.
9. The PEZA reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
