## INVITATION TO BID

## Raising of Perimeter Fence near Pump Station No. 1 to Gate 6, Pump Station No. 6 and Gate 3 to Pump Station No. 8 at the Cavite Economic Zone (PEZA-CEZ 18-07-004)

- The PHILIPPINE ECONOMIC ZONE AUTHORITY-CAVITE ECONOMIC ZONE (PEZA-CEZ), through its Corporate Operating Budget for CY 2018 intends to apply the sum of ₱ 3,149,295.07 being the Approved Budget for the Contract (ABC) to payments under the contract for the "Raising of Perimeter Fence near Pump Station No. 1 to Gate 6, Pump Station No. 6 and Gate 3 to Pump Station No. 8 at the Cavite Economic Zone". Bids received in excess of the ABC shall be automatically rejected at the bid opening.
- 2. The PEZA-CEZ now invites bids for the Raising of Perimeter Fence near Pump Station No. 1 to Gate 6, Pump Station No. 6 and Gate 3 to Pump Station No. 8 at the Cavite Economic Zone. Completion of the Works is required within Ninety (90) calendar days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- 4. Interested bidders may obtain further information from PEZA-CEZ BAC Secretariat and inspect the Bidding Documents at the address given below during Monday to Friday from 8:00 a.m. to 5:00 p.m.
- 5. A complete set of Bidding Documents may be purchased by interested Bidders starting **July 12, 2018** from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos Only (₱5,000.00)**.

It may also be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of PEZA-CEZ, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

- 6. The PEZA-CEZ will hold a **Pre-Bid Conference** on **July 20, 2018, 3:30 pm** at 2<sup>nd</sup> Floor, Function Room, New Administration Building, Cavite Economic Zone, Rosario, Cavite which shall be open only to all interested parties who have purchased the Bidding Documents.
- Bids must be duly received by the BAC Secretariat at the 1<sup>st</sup> Floor, BAC Secretariat, New Administration Building, Cavite Economic Zone, Rosario, Cavite on or before 3:00 pm August 1, 2018. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids submitted beyond 2:00 p.m. will be disqualified to join the bidding process.

**Bid opening** shall be on **August 1, 2018, 3:30 p.m.** at 2<sup>nd</sup> Floor, Function Room, New Administration Building, Cavite Economic Zone, Rosario, Cavite. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. In any case the above dates is declared a special non-working holiday, it will automatically be reset on the next working day.
- 9. The PEZA-CEZ reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
