

Invitation to Bid for the Reconditioning of 2x2000KVA, Allis Electric Power Transformer, 13800V/220-440 at SFB 1 & 2, Mactan Economic Zone

- 1. The Philippine Economic Zone Authority (PEZA), through the Corporate Operating Budget 2013 intends to apply the sum of Php1,600,000.00 being the Approved Budget for the Contract (ABC) to payments under the contract for RECONDITIONING OF 2X2000KVA, ALLIS ELECTRIC POWER TRANSFORMER, 13800V/220-440 AT SFB 1 & 2, MACTAN ECONOMIC ZONE. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PEZA now invites bids for Supply of Labor, Materials, New transformer Oil, Lifting Equipment, Test Instruments, Technical Expertise, Supervision and Safety for the Reconditioning of 2 x 2000KVA, 13800v-220/440v Power Transformer Supplying SFB1 & 2 at MEZ. Delivery of the Service is required within seven (7) days from the receipt of the Notice to Proceed. Duration of the Contract is one hundred twenty (120) calendar days. Bidders should have completed, within one (1) year from the date of submission and receipt of bids, a contract similar to the Project equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from PEZA and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 PM; Monday to Friday.

A complete set of Bidding Documents may be purchased by interested Bidders starting on **29 July 2013** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Php1,000.00:

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

- 5. The PEZA will hold a **Pre-Bid Conference** on **05 August 2013, 2:00 PM** at the Conference Room, 2/f PEZA Administration Building, Mactan Economic Zone, Lapulapu City, which shall be open only to all interested parties who have purchased the Bidding Documents.
- 6. Bids must be delivered to the address below on or before **19 August 2013, 2:00 PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **19 August 2013, 2:00 PM** at the Conference Room, 2/f PEZA Administration Building, Mactan Economic Zone, Lapulapu City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 7. If any of the above date is declared a special non-working holiday, the schedule will automatically be reset on the next working day.
- 8. The PEZA reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
