ZA WHY

CONTRACT FOR THE "OPERATION AND MAINTENANCE OF THE BCEZ SEWERAGE TREATMENT PLANT"

This Agreement made on the V 18 2014 of February 2014 between the PHILIPPINE ECONOMIC ZONE AUTHORITY (hereinafter called the "PEZA") of the one part and ERA INTEGRATED CORPORATON (hereinafter called the "CONTRACTOR") of the other part:

WHEREAS the PEZA invited Bids for certain goods and ancillary services, viz., Operation and Maintenance of the BCEZ Sewerage Treatment Plant of PEZA-Baguio City Economic Zone (PEZA-BCEZ) and has accepted a Bid by the CONTRACTOR for the supply of those goods and ancillary services in the sum of PESOS: One Million Five Hundred Forty-Five Thousand Five Hundred Eight and Fifty-Four Centavos (Php1,545,508.54) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a) the Bid Form and the Price Schedule submitted by the CONTRACTOR;
 - b) the Schedule of Requirements;
 - c) the Technical Specifications;
 - d) the Bid Bulletin, if any;
 - e) the General Conditions of Contract;
 - f) the Special Conditions of Contract;
 - g) PEZA Memorandum dated 06 February 2014; and
 - h) the CONTRACTOR's Notification of Award.

3. In consideration of the payments to be made by the PEZA to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the PEZA to provide the goods and ancillary services and to remedy defects therein conformity in all respects with the provisions of the Conditions of Contract.

The PEZA hereby covenants to pay the CONTRACTOR in consideration of the provision of the good, and ancillary services and the remedial measures therein, the Contract Price or such other sum as may become payable under the provisions of the Conditions of Contract at the time and in the manner prescribed by the Contract.

5. In relation to this Contract, the **CONTRACTOR** shall pay taxes in full and on time and that failure to do so will entitle the **PEZA** to suspend payment on the services delivered by the **CONTRACTOR**.

6. The **CONTRACTOR** shall also present to the **PEZA**, a tax clearance from the Bureau of Internal Revenue as well as a copy of its income and business tax returns duly stamped and received by the BIR and duly validated with the tax payments made thereon.
