Invitation to Bid for the Upgrade/Rehabilitation of the Existing Fire Sprinkler System of PEZA Head Office Building (PEZA-HO-2013-06)

- 1. The Philippine Economic Zone Authority (PEZA), through its Corporate Operating Budget for CY 2012 intends to apply the sum of PESOS: Three Million Six Hundred Thousand Pesos Only (PhP 3,600,000.00) being the Approved Budget for the Contract (ABC) to payment under the contract for the Upgrade/Rehabilitation of the Existing Fire Sprinkler System of PEZA Head Office Building. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PEZA now invites bids for the upgrade of the existing fire sprinkler system, rehabilitation of fire pump room, and replacement of fire pumps. Completion of the Works is required within one hundred sixty (160) working days from receipt of the Notice to Proceed. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
- 4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 5. Interested bidders may obtain further information from PEZA and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m.
- 6. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of PESOS: Five Thousand Only (PhP 5,000.00).
- 7. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, **provided that bidders shall pay the fee for the Bidding Documents not later that the submission of their bids**.
- 8. The PEZA will hold a Pre-Bid Conference on 06 June 2013, 2:00 p.m. at the PEZA Social Hall, 6th Floor, PEZA Building, Roxas Boulevard corner San Luis St., Pasay

City, which shall be **open only to all interested parties who have purchased the Bidding Documents**.

- 9. Bids must be delivered to the address below on or before 11:00 a.m. of 20 June 2013. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
- 10. Bid opening shall be on 20 June 2013, 2:00 p.m. at the PEZA Social Hall, 6th Floor, PEZA Building, Roxas Boulevard corner San Luis St., Pasay City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- 11. In case any of the above dates is declared as a special non-working holiday, it will be automatically reset on the next working day.
- 12. The PEZA reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
