Invitation to Bid for the Asphalt Overlay Project at Mactan Economic Zone

1. The **Philippine Economic Zone Authority (PEZA)**, through its Corporate Budget for the CY 2016, intends to apply the sum of **Nine Million Five Hundred Fifty Thousand Five Hundred Seventy Five and 33/100 Pesos (Php9,559,575.33)** being the Approved Budget for the Contract (ABC), to payments under the contract **Asphalt Overlay Project at Mactan Economic Zone**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PEZA now invites bids for the **Asphalt Overlay Project of the Admin Building Drive, First and Second Avenues, Second and Third Streets, using Instapave Surface Treatment (12mm thk- 2 layers) at Mactan Economic Zone**. Completion of the Works is required within fifty six (56) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest on outstanding capital stock belonging to citizens of the Philippines.
5. Interested bidders may obtain further information from MEZ BAC Secretariat and inspect the Bidding Documents at the address given below from Monday to Friday, 8:00 AM to 5:00 PM.
6. A complete set of Bidding Documents may be acquired by interested Bidders on **06 July 2016** at the address below upon payment of a non-refundable fee for the Bidding Documents in the amount of **Php 10,000.00**.
7. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.
8. The PEZA will hold a **Pre-Bid Conference** on **14 July 2016; 2:00 PM**, at the 2/f PEZA Administration Building, Mactan Economic Zone, Lapulapu City which shall be open only to all interested parties who have purchased the Bidding Documents.
9. Bids must be delivered to the address indicated below on or before **26 July 2016; 2:00 PM** at the 2/f PEZA Administration Building, Mactan Economic Zone, Lapulapu City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
10. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
11. If any of the above date is declared a special non-working holiday, the schedule will automatically be reset on the next working day.
12. The PEZA reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
