



**INVITATION TO BID FOR
THE SUPPLY AND DELIVERY OF MANPOWER,
TOOLS, AND EQUIPMENT FOR THE JANITORIAL SERVICES
REQUIREMENT OF MACTAN ECONOMIC ZONE [RE-BIDDING]**

Contract No. PEZA-MEZ-2017-003

1. The **Philippine Economic Zone Authority [PEZA]** through the 2017 Corporate Operating Budget, intends to apply the sum of **Php1,885,054.92** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply and Delivery of Manpower, Tools, and Equipment for the Janitorial Services Requirement of Mactan Economic Zone [Re-Bidding]**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **PEZA** now invites bids for **Supply and Delivery of Manpower, Tools, and Equipment for the Janitorial Services Requirement of Mactan Economic Zone [Re-Bidding]**. Delivery of the Goods is required within ten (10) days from receipt of the Notice to Proceed and is required for one (1) year which may be extended/renewed to a maximum of two (2) years. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from **PEZA** and inspect the Bidding Documents at the address given below during **8:00 AM to 5:00 PM; Monday to Friday**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **21 February 2017** from the address below, and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Php1,000.00**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **PEZA** will hold a **Pre-Bid Conference** on **01 March 2017; 2:00 PM** at the **Conference Room, 2/f PEZA Administration Building, Mactan Economic Zone, Lapulapu City, Cebu**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **13 March 2017; 2:00 PM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **13 March 2017; 2:00 PM** at **Conference Room, 2/f PEZA Administration Building, Mactan Economic Zone, Lapulapu City, Cebu**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. If any of the above date is declared a special non-working holiday, the schedule will automatically be reset on the next working day.
9. The **PEZA** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
