



Invitation to Bid for Tiles Installation at MEZ Administration Building

Contract No. PEZA-MEZ-2017-006

1. The **Philippine Economic Zone Authority**, through its Corporate Budget for the YR2017¹ intends to apply the sum of **Two Million One Hundred Fifty Five Thousand Nine Hundred Fifty Five and 81/100 Pesos (Php2,155,955.81)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Tiles Installation at MEZ Administration Building**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Philippine Economic Zone Authority** now invites bids for **Tiles Installation at MEZ Administration Building**.² Completion of the Works or project duration is 90 calendar days from the date of receipt of Notice to proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the **Philippine Economic Zone Authority** and inspect the Bidding Documents at the address given below from 8:00 am to 5:00 pm.
5. A complete set of Bidding Documents may be acquired by interested bidders on 18 November 2017 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php5,000.00**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the

Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The **Philippine Economic Zone Authority** will hold a Pre-Bid Conference³ on **25 November 2017** at 2nd floor, PEZA Administration Building, Mactan Economic Zone, Lapu-lapu City which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before 2:00 pm on **07 December 2017**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on **07 December 2017** at 2/f PEZA Administration Building, Mactan Economic Zone, Lapu-lapu City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. If any of the above date is declared a special non-working holiday, the schedule will automatically be reset on the next working day.
9. The **Philippine Economic Zone Authority** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
