## **INVITATION TO BID**

## Repair and Repainting of Concrete Gutter Curbs along Main and Major Secondary Road at the Cavite Economic Zone (CEZITB 2021-11-016)

- The PHILIPPINE ECONOMIC ZONE AUTHORITY-CAVITE ECONOMIC ZONE (PEZA-CEZ), through the Corporate Operating Budget for CY 2021 intends to apply the sum of Pesos: One Million Four Hundred Fifty Seven Thousand Seven Hundred Fifty One and 98/100 Only (₱1,457,751.98) being the Approved Budget for the Contract (ABC) to payments under the contract for Repair and Repainting of Concrete Gutter Curbs along Main and Major Secondary Road at the Cavite Economic Zone (CEZITB 2021-11-016). - 3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- A complete set of Bidding Documents may be acquired by interested bidders on <u>03 November 2021</u> from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of <u>Ten Thousand Pesos Only</u> (₱10,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
- 6. The PEZA-CEZ will hold a Pre-Bid Conference on <u>11 November 2021, 2:30pm</u> through videoconferencing / webcasting via Microsoft Teams, which shall be open to prospective bidders. The BAC Secretariat shall email invite/meeting ID and password to those who signify their intent via email below.

- Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, on or before <u>2:00pm, 23 November 2021</u>. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on <u>23 November 2021, 2:30pm</u> at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. In any case the above dates is declared a special non-working holiday, it will automatically be reset on the next working day.
- 11. The PEZA-CEZ reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
