MINUTES OF PRE-BID CONFERENCE

The **Pre-Bid Conference** for the **Procurement of Network Access Control (NAC) Solution for Public Economic Zones: BCEZ, CEZ & MEZ (PEZA-HO-2019-10)**, held at PEZA, 5th floor, PNOG Building 5, Energy Center, Rizal Drive, Bonifacio Global City, Taguig City, was called to order at 2:35 PM. on **18 July 2019**, and was presided by the BAC Chairman.

1. The BAC Chairman Tereso O. Panga introduced the present BAC members, BAC Secretariat and representative from end-user unit.
2. On the side of the interested bidders, there were four (4) representatives from two (2) contractors. There was no observer present during the pre-bid conference.
3. The question raised by one of the suppliers are as follows:
 - a. The bidder clarified on the project title if is a new procurement since the Terms of Reference states that NAC solution must be of the same brand as the existing network equipment.
 - b. The end-user answered "Yes", it is a new procurement for the public ecozones and said to read the TOR on the compatibility requirement.
 - c. The brand required is not offered/available to one of the prospective bidder. Hence, they are trying to make a manifestation if other brands will be possible, as long as it is compliant. The bidder eventually understood that same brand as the existing Network equipment and Wireless LAN Controller installed in the Head Office is being procured to avoid incompatibility issues in integrating with the public economic zones.
4. The BAC Vice-Chairman clarified that if there are any other clarifications, the bidders can email the BAC Secretariat.
5. The BAC Vice-Chairman reiterated that the address for **submission of the bids** is Philippine Economic Zone Authority, BAC Secretariat, 5/F, Bldg. 5, DOE-PNOG Complex, Rizal Drive, BGC, Taguig City.

6. The **deadline for submission of bids is July 30, 2019, 11:00 AM following the clock time at the 5/F, Bldg. 5.**

There having no other remaining topics for discussion, the Pre-Bid Conference was adjourned at 2:48 PM.
