# CONTRACT FOR THE UPDATING/CONCEPT AND DESIGN DEVELOPMENT OF THE PEZA WEBSITE

WHEREAS the Entity invited Bids for certain services, viz., **Updating/Concept and Design Development of the PEZA Website** and has accepted a Bid by the Supplier for the delivery of such services in the sum of Three Hundred Thirty Six Thousand Pesos Only (\$\beta\$ 336,000.00 inclusive of VAT) (hereinafter called "the Contract Price").

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) Request for Quotations
  - (b) Terms of Reference; and
  - (c) The Entity's Notification of Award.
- 3. The Website Development shall consist of the following:

# Programming

Programming of a dynamic and client-maintained website from conversion of graphic design to a working web structure, covering front-end and back-end development. Drupal, as one of DICT's prescribed Content Management System (CMS) and its prescribed template shall be used. Individual entries on CMS section can be added, modified, or deleted while static sections shall be a single editable page.

- II. Design
  - a. Two (2) design studies / proof of concept (with 6 sample pages each study; in jpeg/pdf)
    b. Two (2) sets of revisions on the approved study / proof of concept (jpeg/pdf)

  - c. Comprehensives, Revisions and Testing
- III. Final Artwork
  - a. Desktop layouting and encoding
  - b. Digital Image Manipulation (72 pixels per inch; approved final images shall be submitted together with their PSD files)
- IV. Deployment

#### Training

One (1) session training on how to manage contents on Drupal CMS.

#### Hosting

The Entity shall provide appropriate access to its hosting facility for the Supplier to deploy the new created website.

## **Duration of Work**

Deliverables shall be delivered within forty (40) working days from the receipt of the Notice to Proceed, inclusive of the training period.

### **Technical Support and Maintenance**

The Supplier shall warrant the newly created website for a period of one hundred eighty (180) calendar days.

Payment breakdown shall be as follows:

15% Submission of two (2) design studies / proof of concept

Final approval / signoff of website design 15%

15% Completion of usability and user acceptance testing

Acceptance on Final Review 15%

25% Deployment and hosting of the newly created website

5% Submission of approved final images with their respective PSD files

10% Completion of Drupal CMS training

- 5. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the services and to remedy defects therein in conformity in all respects with the provisions of the Contract
- 6. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
- 7. If the Supplier fails to satisfactorily deliver the services within the period specified in this Contract inclusive of duly granted time extensions if any, the Entity shall, without prejudice to its other remedies under this Contract and under the applicable law, deduct from the Contract Price, as liquidated damages, the applicable rate of one tenth (1/10) of one (1) percent of the cost of the unperformed portion for every day of delay until actual delivery or performance. The maximum deduction shall be ten percent (10%) of the amount of contract. Once the maximum is reached, the Entity may rescind or terminate the Contract, without prejudice to other courses of action and remedies open to it.
- 8. In relation to this Contract, the Supplier shall pay taxes in full and on time and the failure to do so will entitle the Entity to suspend payment on the services delivered by the Supplier.
- 9. The Supplier shall also present to the Entity a tax clearance from the Bureau of Internal Revenue as well as a copy of its income and business tax returns duly stamped and received by the BIR and duly validated with the tax payments made thereon.
