

AGREEMENT

Relocation and Commissioning of PEZA's Data Center Network Infrastructure

THIS AGREEMENT made on the 10 day of JAN 10 2020 2020 between **PHILIPPINE ECONOMIC ZONE AUTHORITY** (hereinafter called "the Entity") of the one part and **TRENDS & TECHNOLOGIES, INC.** (hereinafter called "the Supplier") of the other part:

WHEREAS, the Entity had previously invited Bids for certain goods and ancillary services, viz., Procurement of Maintenance Agreement for CISCO Wireless Network Equipment Deployed at the Head Office and Public Economic Zones, CEZ, MEZ & BCEZ and Renewal of Licenses Fortinet Network Firewall Equipment and has accepted the Bid of the Supplier for the supply of those goods (hereinafter referred to as "Original Contracts");

WHEREAS, the Entity is moving its head office from Department of Energy Compound, Bonifacio Global City, Taguig City to its new location at the 8th, 9th and 10th Floor of the Double Dragon West Wing Building, Pasay City;

WHEREAS, the Entity has requested for quotation from the Supplier for the Relocation and Commissioning of PEZA's Data Center Network Infrastructure in the amount of Three Million Three Hundred Thousand Pesos Only (Php3,300,000.00) considering that the Original Contracts are still under warranty;

WHEREAS, the Supplier has offered the quotation for the Relocation and Commissioning of PEZA's Data Center Network Infrastructure in the amount of Three Million Two Hundred Ninety Five Thousand Pesos only (Php3,295,000.00);

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. The bidding documents related to the Original Contracts shall be deemed to form and be read and construed as part of this Agreement. The same shall include but not limited to:

- (a) Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
- (b) Schedule of Requirements;
- (c) General Conditions of Contract;
- (d) Special Conditions of Contract;
- (e) Performance Security; and
- (f) Entity's Notice of Award.

2. The provisions of the document "Request for Quotation" including its Annexes, with RFQ No. 2019-11-00063 dated 20 November 2019 shall also be deemed to form and be read and construed as part of this Agreement.

3. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract, which are part of the bidding documents in the Original Contracts.

4. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby commits to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Conditions of Contract.

5. The Entity hereby commits to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Conditions of Contract, as well as the Request for Quotation, including Annexes, at the time and in the manner prescribed therein.

6. In relation to this Agreement, the Supplier shall pay taxes in full and on time and that failure to do so will entitle the Entity to suspend payment on the goods and services delivered by the Supplier.

7. The Supplier shall also present to the Entity a tax clearance from the Bureau of Internal Revenue as well as a copy of its income and business tax returns duly stamped and received by the BIR and duly validated with the tax payments made thereon.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


