Objective:

The project objective is to relocate the existing Server Racks UPS, and PACU from its current location to the new PEZA site. Relocation project works includes decommissioning, dismantling, hauling, delivery, positioning and installation, testing and commissioning, of the existing equipment on the new IT Server Room.

Scope of Work:

- 1.0 Decommissioning, Dismantling, Delivery, Hauling, Installation, Testing and Commissioning of two (2) units Existing 6KVA Rack mountable UPS
 - 1.1 Conduct decommissioning procedures for the existing two (2) units 6KVA UPS including its External Battery.
 - 1.2 Disconnection and dismantling of existing two (2) units 6KVA UPS and External Battery.
 - 1.3 Delivery and hauling of UPS from the old office to the new PEZA site location (10F MIS Server Room).
 - 1.4 Supply and installation of new wirings and breakers within the IT Server Room for the two (2) units 6KVA UPS.
 - 1.5 Installation and mounting of existing two (2) units 6KVA UPS and External Battery on the designated rack space.
 - 1.6 Connection and termination of the newly installed wirings on each input terminals of the 6KVA.
 - 1.7 Conduct testing and commissioning of the existing two (2) units 6KVA UPS and External Battery.

 - 2.2 Disconnection of existing mechanical pipings for the existing (2) units 3TR PACU, indoor and outdoor units.
 - 2.3 Disconnection of existing electrical wirings of existing two (2) units 3TR PACU (indoor and outdoor units).
 - 2.4 Dismantling the PACU indoor and outdoor units from its current positions.
 - 2.5 Delivery and hauling of existing two (2) units 3TR PACU (indoor and outdoor) from the old PEZA office to the new office location (10F, MIS Server Room).
 - 2.6 Supply of new PACU outdoor unit to accommodate the longer piping requirements of new site.
 - 2.7 Complete supply and installation of mechanical pipings for refrigerant lines from Server Room (indoor unit) to Roofdeck (outdoor unit)
 - 2.8 Complete supply and installation of mechanical pipings for humidifier and drain lines from Server room to tapping source.
 - 2.9 Supply and installation of PACU (indoor and outdoor unit) electrical wirings, control wirings breakers, and ECB, complete with roughing-ins, hangers and supports.
 - 2.10 Installation of PACU indoor and outdoor units, complete with accessories, platforms and supports.
 - 2.11 Conduct testing and commissioning of newly installed two (2) units 3TR Air-cooled, Upflow, PACU.

 - 3.3 Delivery and hauling of (2) 42U Server Racks from the old office to the new PEZA site location (10F MIS Server Room).
