**SUBJECT MATTER: RECOMMENDATION FOR AWARD**

**PROJECT DESCRIPTION: PROCUREMENT THROUGH PUBLIC BIDDING OF THE PROJECT ENTITLED "CONSULTANCY SERVICES FOR THE TIER 2 STRUCTURAL INTEGRITY STUDY OF PEZA-BCEZ SFB NO. 1 (RE-BID)."**

**WHEREAS**, Purchase Request (PR) No. BC-2018-08-011 was approved by the Procuring Entity for the public bidding of the project entitled, "CONSULTANCY SERVICES FOR THE TIER 2 STRUCTURAL INTEGRITY STUDY OF PEZA-BCEZ SFB NO. 1 (RE-BID)" with an Approved Budget of Contract (ABC) in the amount of Php5,561,230.08;

**WHEREAS**, on 12 September 2018, the BCEZ - BAC conducted Pre-Procurement Conference for the project;

**WHEREAS**, on 05 November 2018, the BCEZ - BAC has advertised a Request for Expression of Interest in the PEZA website, in the GEPS and a conspicuous place at the premises of the PEZA-BCEZ continuously for 7 days, and advertised the same on 04 November 2018 in the Philippine Daily Inquirer;

**WHEREAS**, on 14 November 2018 during the Eligibility Check and Shortlisting, the following were shortlisted and determined as eligible bidders: 1) A.C. Ong Consulting Inc.; 2) Ernesto S. De Castro. PhD and Associates; 3) GIBMA Engineering Services.

**WHEREAS**, on 23 November 2018 during the Pre-Bid Conference, the following shortlisted bidders attended the activity: 1) Ernesto S. De Castro. PhD and Associates; 2) GIBMA Engineering Services.

**WHEREAS**, on 07 December 2018 during the Opening of Bids, A.C. Ong Consulting, Inc. and GIBMA Engineering Services submitted bid proposals, thereafter, the submitted bid documents were publicly opened. The bid proposal of GIBMA Engineering Services was adjudged as the Highest Rated Bid with the result as follows:

**WHEREAS**, the BCEZ-BAC conducted Bid Evaluation for the project and issued Recommendation for Approval of Ranking by the Head of Procuring Entity;



**WHEREAS**, the BCEZ-BAC issued Notification for Negotiation to the Highest Rated Bid, GIBMA Engineering Services and Negotiation was conducted on 18 December 2018;

**WHEREAS**, on 19 December 2018 to 14 January 2019, the BCEZ-BAC conducted post qualification evaluation of the Technical and Financial Components of the submitted bid documents, and the Post Qualification documents required from GIBMA Engineering Services and found to be substantially complying and considered as the Highest Rated Responsive Bid;

**NOW, THEREFORE, RESOLVED AS IT IS HEREBY RESOLVED:**

1. To declare GIBMA Engineering Services as the Highest Rated Responsive Bidder for the "CONSULTANCY SERVICES FOR THE TIER 2 STRUCTURAL INTEGRITY STUDY OF PEZA-BCEZ SFB NO. 1 (RE-BID)"; and
2. For the OIC - Deputy Zone Administrator to recommend the approval of the foregoing findings to the Head Office and award the contract to GIBMA Engineering Services in the amount of P3,623,200.00.
