WHEREAS, the Philippine Economic Zone Authority conducted the second public bidding for the procurement of **Desktops and Laptops for PEZA Head Office (PEZA-HO-2021-02)** with an Approved Budget Contract (ABC) in the amount of PhP14,305,000.00 for Lot 1 and PhP360,000.00 for Lot 2;

WHEREAS, on 08 July 2021, the Bids and Awards Committee (BAC) issued Resolution No. 2021-02FB to declare failure of bidding for the first bidding due to no bid was submitted for all lots during the Opening of Bids held on 30 June 2021;

WHEREAS, on 27 August 2021, In view of the second bidding, the Bidding Documents were posted and Pre-bid Conference was conducted on 8 September 2021 whereby eight (8) prospective bidders participated;




