BAC RESOLUTION NO. 2020-02

WHEREAS, on 14 January 2020, the Bids and Awards Committee (BAC) received a memorandum from DM Elmer H. San Pascual (PPRG) requesting the conduct of procurement of Special Token Watches through Direct Contracting.

The request is premised on the following:

1. The subject special token watches (107 units) shall be given to PEZA employees with 25 or more years of government service (as PEZA employees) in celebration of PEZA's Silver Anniversary on February 25, 2020;
2. The survey/market study conducted by the end-user supports procurement through direct contracting with the identified supplier that offered the most advantageous price to the government; and
3. The estimated total cost (Php318,902.80) of the special token watches at Php2,890.50 per unit shall be chargeable to the 2020 Corporate Operating Budget under Special Events, as approved inclusion in PPRG Budget.

WHEREAS, based on the foregoing, the subject alternative mode of procurement, thru Direct Contracting, finds basis under Section 50 of the 2016 Revised Implementing Rules and Regulations of R. A. No. 9184, given that the value does not exceed PhP1 million, and no suitable substitute items in the market can be obtained at a more advantageous terms than the one being offered by the identified direct supplier;

WHEREAS, the end-user conducted a comparative survey of prices of timepieces available in the market based on the approved budget and the price of an identified model/brand, as follows:

WHEREAS, Newtrends International Corporation (exclusive distributor of Timex watches) offered a discounted price in the amount of **PhP2,890.40** per unit, as indicated in its price quotation in response to the Request for Quotation sent by the BAC Secretariat on 15 January 2020 (RFQ 2020-01-002); The said price is inclusive

of VAT and the customization by inscribing the PEZA logo commemorating its 25th Anniversary.

NOW THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED, to recommend to the Director General, as Head of the Procuring Entity, the award for the procurement through Direct Contracting of **107 Timex Wristwatches** (model TWEG1539E) in the amount of **PhP2,980.40 per unit inclusive of VAT to NEWTRENDS INTERNATIONAL CORPORATION.**
