

<p>Bidders should have completed from Y2018 to present a contract similar to the requirement. The Eligibility Check/Screening and Preliminary Examination of Bids shall use nondiscretionary "pass/fall" criterion.</p>	<p>Bidders should have completed from Y2013 to present a contract similar to the requirement.</p> <p>Section 23.4.2.4 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184 states that: "The prospective bidder must have completed an SLCC that is similar to the contract to be bid, and whose value, adjusted to current prices using the PSA consumer price indices, must be at least fifty percent (50%) of the ABC to be bid: Provided, however, That contractors under Small A and Small B categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than the Allowable Range of Contract Cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB. For Foreign-funded Procurement, the GoP and the foreign government/foreign or international financing institution may agree on another track record requirement. Moreover, a contract shall be considered "similar" to the contract to be bid if it has the same major categories of work. The Procuring Entity may clarify in the Bidding Documents what is regarded as major categories of work." For infrastructure projects, only the Statement of the bidder's Single Largest Completed Contract similar to the contract to be bid amounting to at least fifty percent (50%) of the ABC is allowed.</p> <p>The Eligibility Check/Screening and Preliminary Examination of Bids shall use nondiscretionary</p>
