1. Will the list of PEZA firms be uploaded in the queuing system?	<ul style="list-style-type: none"> <li>• Yes. PEZA will provide the list in excel form to be uploaded by the provider in the system.</li> </ul>
2. How many calendar days is required for the project to be delivered?	<ul style="list-style-type: none"> <li>• Thirty (30) calendar days upon issuance of Notice to Proceed (NTP)</li> </ul>
3. What is the acceptable size for the PC and tablet monitor?	<ul style="list-style-type: none"> <li>• Minimum requirement is as specified in the technical requirement.</li> </ul>
4. Is it required for the ticketing kiosk to have a separate PC?	<ul style="list-style-type: none"> <li>• Ticketing Kiosk must have a Touchscreen Monitor and built-in PC which is separate from PC server.</li> </ul>
5. Who will provide the network connection?	<ul style="list-style-type: none"> <li>• PEZA will provide wireless connection.</li> </ul>

Technical Specifications, page 20 of the Bidding Documents, it states that:            1 unit 32" LED Backlight</p> <ul style="list-style-type: none"> <li>- Built-in ISDB-T Receiver</li> <li>- HD Ready</li> <li>- Vidaa U2 Operating System</li> <li>- Anyview cast, VEWD App Store</li> <li>- Support USB Device: JPEG MP3</li> <li>- <b>1 HDMI input port to HDMI output ports</b></li> </ul> <p>We would like to clarify if the description of the above 32 inches LED Backlight "1 HDMI input port to 8 HDMI output ports" is a typographical error since the said description may refer to the HDMI Splitter specification. With this, may we request the removal of the word "to 8 HDMI output ports"?</p>	<ul style="list-style-type: none"> <li>• The specifications should not include 1 HDMI input port to HDMI output ports.</li> </ul>

Technical Specifications, page 20 of the Bidding Documents, it states that: 1-unit Ticketing Kiosk (Auto Cut Thermal Ticket Printer with Touch screen Interface)</p> <p>Metal Kiosk 17" anti-dust LED back-lit touchscreen monitor Processor: Quad core 2.0 GHz RAM: 4GB Storage: 120GB Connectivity: LAN and Wi-Fi <b>Thermal Paper: 57mm paper with auto cutter and printer controller</b> Allow user to print logo or other images on any part of the ticket Capable of playing videos or image slide shows Dimension based on the manufacturer design</p> <p>a) May we seek your approval to relax the required specification for the Ticketing Kiosk "Thermal Paper: 57mm paper with auto cutter and printer controller" to "Thermal Paper" 57mm or 80mm paper with auto cutter and printer controller" be admissible for this project? Since some of the readily available unit of Kiosk comes with different size of printer paper compatibility. The said option 80mm paper is also the standard size and available in the Philippine Market.</p> <p>In Section VII. Technical Specifications, page 20 of the Bidding Documents, it states that: 3 boxes Thermal paper (57mm x 25mm) – 100 rolls per box</p> <p>b) May we also request to relax the specification "Thermal Paper (57mm x 25mm) – 100 rolls per box" to "Thermal Paper (57mm or 80mm width) – 100 rolls per box"?</p>	<ul style="list-style-type: none"> <li>● 57mm paper size is preferred to lower long term expenses on consumables.</li> </ul>
