CERTIFICATE OF BOARD RESOLUTION

This is to certify that at the Board Meeting of the Philippine Economic Zone Authority (PEZA) held on 10 May 2001, during which a quorum was present, the following resolution was approved:

RESOLUTION NO. 01-152

WHEREAS, to ensure that the raw materials imported by economic zone export enterprises tax and duty-free are used only in the manufacture of products that are finally exported, the EPZA-Bureau of Customs Memorandum of Agreement provides that all import and export shipments be accompanied by PEZA Police Escorts;

WHEREAS, in case of shipments of raw materials and components to be processed under sub-contracting arrangements from one ecozone to another, or from one ecozone to a customs bonded manufacturing warehouse outside of the ecozones, in lieu of posting surety bonds, PEZA-registered enterprises may arrange to have said shipments accompanied by PEZA Police Escorts during transshipment through the customs territory;

WHEREAS, management saw the need to rationalize the existing PEZA Police Escort Fee arrangement;

WHEREAS, in the PEZA Planning Workshop, it has been agreed that the existing schedule of police and escort fees and allowances should be revised towards achieving three important policy objectives: (1) equitable distribution of the costs of providing police escort services for import and export shipments, which is consistent with PEZA's mission to encourage dispersal of ecozones in the countryside; (2) granting escort allowances that will translate to a more equitable distribution of additional remuneration among PEZA Police Escort, regardless of assignment location; and (3) increasing revenues from police escort services to contribute to the support of the PEZA overhead;

RESOLVED, THEREFORE, that the following Escort Fees and Allowances for Import and Export Shipments and for Inter-Economic Zone Shipments is hereby approved:
