BAC RESOLUTION NO. 2023-08 (SVP)

WHEREAS, the PEZA-Corporate Planning Department (CPD) through Bids and Award Committee (BAC) conducted the Procurement of **Consultancy Services - Crafting of PEZA Strategic Plan (2023-2028)** with an Approved Budget for the Contract (ABC) of Eight Hundred Fifty Thousand Pesos in Philippine Currency (PhP 850,000.00) through Small Value Procurement (SVP) under Section 53.9 of the Updated 2016 Revised IRR of RA No. 9184;

WHEREAS, the Request for Quotation (RFQ) No. BAC-2023-03 for the aforementioned procurement was posted for a period of ten (10) calendar days or from 13 March 2023 until 23 March 2023 in Philippine Government Electronic Procurement System (PhilGEPs) website, PEZA website, and PEZA Bulletin Board located on the 8th, 9th and 10th Floor of the PEZA Head Office;

WHEREAS, on 23 March 2023 at exactly 5:00 P.M., the Deadline of RFQ submission, only seven (7) bidders submitted proposals as shown hereunder:







