

**Contract Agreement Form for the Procurement of Goods (Revised)**  
[Not required to be submitted with the Bid, but it shall be submitted within ten (10) days after receiving the Notice of Award]

**CONTRACT AGREEMENT**

This Agreement made on the 8th day of November 2023 at Pasay City, by and between:

**PHILIPPINE ECONOMIC ZONE AUTHORITY**, a government corporation created and operating under Republic Act No. 7916, as amended, with office address at the 10th Floor DoubleDragon Center West Building, DD Meridian Park, Macapagal Avenue, Pasay City, represented herein by its Director General, **TERESO O. PANGA**, who is duly authorized, hereinafter referred to as "**the Entity**";

-and-

**TUV NORD PHILIPPINES INC.**, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines with office address at Units 603-607 Common Goal Tower Finance corner Industry Streets, Madrigal Business Park, Ayala Alabang, Muntinlupa City, represented herein by its General Manager, **JOCELYN MAGAT**, who is likewise duly authorized, hereinafter referred to as "**the Supplier**";

**WHEREAS**, the Entity invited Bids for certain goods and ancillary services, particularly the **Procurement to Engage the Services of a Certifying Body for PEZA Re-certification to ISO 9001:2015 (PEZA-HO-2023-12)** with an Approved Budget of Contract in the amount of One Million and Nine Hundred Thousand Pesos (P1,900,000.00);

**WHEREAS**, in the public bidding that was conducted for the above-mentioned procurement, the Supplier submitted, and the Entity accepted, the bid most advantageous to the Entity for the supply of those goods and services in the amount of **Eight Hundred Ninety-Nine Thousand Three Hundred Sixty Pesos in Philippine Currency (PhP899,360.00)**, hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;




- iii. General and Special Conditions of Contract; and
  - iv. Supplemental or Bid Bulletins, if any.
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Eight Hundred Ninety-Nine Thousand Three Hundred Sixty Pesos in Philippine Currency (PhP899,360.00)**, the Supplier agrees to be the Certifying Body for PEZA Re-certification to ISO 9001:2015 in accordance with its Bid.
  4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.



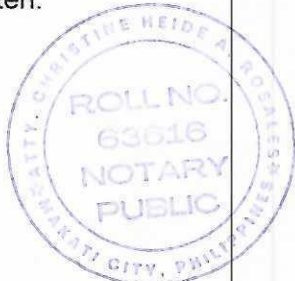
