

## Contract Agreement Form

### Procurement of Movers/Haulers for the Relocation of PEZA Head Office Files/Documents and Equipment/Properties (PEZA-HO-2020-02)

THIS AGREEMENT made the 25 day of Aug 20 20 between:

**PHILIPPINE ECONOMIC ZONE AUTHORITY**, a government-owned and controlled corporation organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office address at 10th floor, Double Dragon Center West Building, DD Meridian Park, Macapagal Avenue, Pasay City, 1302, represented herein by its Deputy Director General for Finance and Administration, **JUSTO PORFIRIO LI. YUSINGCO**, duly authorized for the purpose, hereinafter referred to as "PEZA" and called the "Entity"

- and -

**ALL TRANSPORT NETWORK, INC.** a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal place of business at No. 3 Sta Agueda Avenue, PASCOR Drive, Paranaque City 1700, represented herein by its Special Projects Manager, **VERNADETTE G. VIVERO**, duly authorized for this purpose, hereinafter referred to as "ATN" and called the "Supplier" of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, **Movers/Haulers for the Relocation of PEZA Head Office Files/Documents and Equipment/Properties (PEZA-HO-2020-02)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION NINE HUNDRED EIGHTY-SEVEN THOUSAND NINE HUNDRED NINETY-EIGHT PESOS (PHP 1,987,998.00)**, hereinafter called "the Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;

- (e) the Special Conditions of Contract;
- (f) the Performance Security; and
- (g) the Entity's Notice of Award.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract

4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
