



## **PHILIPPINE ECONOMIC ZONE AUTHORITY**

### **Invitation to Bid for the Proposed Rehabilitation of MEZ Secondary Roads Using Instapave Surface Treatment *PEZA MEZ No. 2023-002***

1. The **Philippine Economic Zone Authority**, through the Corporate Operating Budget (COB) for C.Y 2023 intends to apply the sum of **Nine Million Eight Hundred Twenty Nine Thousand Two Hundred Twenty pesos and 60/100 (ABC Php 9,829,220.60)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Proposed Rehabilitation of MEZ Secondary Roads Using Instapave Surface Treatment** and *Project Identification Number PEZA MEZ No. 2023-002*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Philippine Economic Zone Authority** now invites bids for the above Procurement Project. Completion of the Works is required within sixty (60) working days. Bidders should be operating in the construction business for five (5) years and should have completed a contract similar to the Project (**Application of Asphalt Overlay using Instapave Surface Treatment**) within five (5) years from the submission of bid documents. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **Philippine Economic Zone Authority** and inspect the Bidding Documents at the address given below from **9:00-6:00pm**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **26 June 2023** from the given address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php 10,000.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, or through email.
6. The **Philippine Economic Zone Authority** will hold a Pre-Bid Conference<sup>1</sup> and Opening of Bids on the following dates below at Conference Room, PEZA Administration Building, AAI Compound, Mactan Economic Zone, Lapu-lapu City which shall be open to prospective bidders.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
