INVITATION TO BID FOR OPERATIONS AND MAINTENANCE MANAGEMENT OF THE MACTAN ECONOMIC ZONE SEWERAGE TREATMENT PLANT AND WATER RECLAMATION PLANT (MEZ STP-WRP) RE-BIDDING

1. The **Philippine Economic Zone Authority**, through the Approved Corporate Budget for the Year 2024 intends to apply the sum of **Four Million Two Hundred Thousand Sixty-five Thousand Six Hundred Twenty-Eight and 34/100 Pesos Only [Php4,265,628.34]** being the ABC to payments under the contract for **Operations and Maintenance Management of the Mactan Economic Zone Sewerage Treatment Plant and Water Reclamation Plant (MEZ STP AND WRP) Re-bidding** with Project identification number **PEZA MEZ 2024-004**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Philippine Economic Zone Authority** now invites bids for the above Procurement Project. Delivery of the Goods is required **upon receipt of the Notice to Proceed** and **contract duration is one (1) year** therefrom unless earlier revoked by PEZA due to unsatisfactory performance of the contractor. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from **MEZ BAC Secretariat** and inspect the Bidding Documents at the address given below during **from Monday to Friday from 8:00AM-5:00P.M..**
5. A complete set of Bidding Documents may be acquired by interested Bidders on **15 July 2024** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos only [Php5,000.00]**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The **Philippine Economic Zone Authority** will hold a Pre-Bid Conference¹ on **24 July 2024**. at MEZ Function Hall, 2ND Floor, PEZA MEZ Administration Building, Mactan

Economic Zone, Lapu-lapu City, and through videoconferencing via MS. Teams <https://tinyurl.com/mv8knp8m> , which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below, on or before **05 August 2024 at 10:00 A.M.** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **05 August 2024 at 10:00 A.M** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. In the case the above date is declared a special non-working holiday, it will automatically be reset on the next working day.
11. The **Philippine Economic Zone Authority** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
