Invitation to Bid for Proposed Rehabilitation of MEZ Secondary Roads Using Instapave Surface Treatment at Mactan Economic Zone

1. The **Philippine Economic Zone Authority**, through the Approved Corporate Budget for the Year 2024 intends to apply the sum of **Nine Million Nine Hundred Seven Thousand Eight Hundred Sixty-Seven and 02/100 (Php9,907,867.02)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Proposed Rehabilitation of MEZ Secondary Roads Using Instapave Surface Treatment at Mactan Economic Zone and Project Identification Number PEZA MEZ 2024-003**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Philippine Economic Zone Authority** now invites bids for the above Procurement Project. Project duration shall be for a period of Seventy-five (75) calendar days from the issuance of Notice to Proceed (NTP). Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **MEZ BAC Secretariat** and inspect the Bidding Documents at the address given below from **Monday to Friday from 8:00AM-5:00P.M.**
5. A complete set of Bidding Documents may be acquired by interested bidders on **28 May 2024** from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (Php10,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The **Philippine Economic Zone Authority** will hold a Pre-Bid Conference¹ on **06 June 2024 at 10:00A.M.** at MEZ Function Hall, 2ND Floor, PEZA MEZ Administration

Building, Mactan Economic Zone, Lapu-lapu City, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before **25 June 2024; 10:00 A.M.**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **25 June 2024 at 10:00 A.M.** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. In the case the above date is declared a special non-working holiday, it will automatically be reset on the next working day.
11. The **Philippine Economic Zone Authority** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
