INVITATION TO BID

CONSTRUCTION OF FABRICATION FACILITY AND STORAGE WAREHOUSE AT PUMP STATION NO. 1 AT THE CAVITE ECONOMIC ZONE (CEZITB 2022-06-008)

1. The PHILIPPINE ECONOMIC ZONE AUTHORITY-CAVITE ECONOMIC ZONE (PEZA-CEZ), through the Corporate Operating Budget for CY 2022 intends to apply the sum of **Pesos: Three Million Five Hundred Fifty-Three Thousand Seven Hundred Eleven and 66/100 Only (₱3,553,711.66)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Construction of Fabrication Facility and Storage Warehouse at Pump Station No. 1 at the Cavite Economic Zone (CEZITB 2022-06-008)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PEZA-CEZ now invites bids for the above Procurement Project. Completion of the Works is required within **one hundred twenty (120) calendar days**. Bidders should have completed, within **the last five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **CEZ-BAC Secretariat** and inspect the Bidding Documents at the address given below from **Monday to Friday from 8:00 a.m. to 5:00 p.m.**
5. A complete set of Bidding Documents may be acquired by interested bidders on **28 June 2022** from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos Only (₱5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The PEZA-CEZ will hold a Pre-Bid Conference on **06 July 2022, 1:30pm** at **2nd Floor, Function Room, New Administration Building, Cavite Economic Zone, Rosario, Cavite, and/or through videoconferencing / webcasting via Microsoft Teams**, which shall be open to all prospective bidders. For bidders who

wish not to be physically present during the pre-bid conference, the BAC Secretariat shall email invite/meeting ID and password to those who signify their intent via email below.

7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, on or before **1:00pm, 18 July 2022**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **18 July 2022, 1:30pm** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. In any case the above date is declared a special non-working holiday, it will automatically be reset on the next working day.
11. The PEZA-CEZ reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
