**REHABILITATION/IMPROVEMENT OF DRAINAGE LINE ALONG SOUTH AVENUE,
 WEST AVENUE, AND 6TH STREET AT THE CAVITE ECONOMIC ZONE
 (CEZITB 2022-11-021)**

1. The PHILIPPINE ECONOMIC ZONE AUTHORITY-CAVITE ECONOMIC ZONE (PEZA-CEZ), through the Corporate Operating Budget for CY 2022 intends to apply the sum of **Pesos: Fifteen Million Five Hundred Thirty-Nine Thousand Thirty-Eight and 79/100 Only (₱15,539,038.79)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Rehabilitation/Improvement of Drainage Line along South Avenue, West Avenue, and 6th Street at the Cavite Economic Zone (CEZITB 2022-11-021)**.
2. The PEZA-CEZ now invites bids from technically, legally, and financially capable contractors for the above procurement project to participate in the Negotiated Procurement – Two Failed Biddings in accordance with Section 53.1 of the Revised IRR of R.A.9184, otherwise known as the Government Procurement Reform Act (GPRA).
3. Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders/contractors may obtain further information from CEZ-BAC Secretariat and inspect the Bidding Documents at the address given below from **Monday to Friday, 8:00 a.m. to 5:00 p.m.**
5. A complete set of negotiation documents may be acquired by interested Bidders on **November 28, 2022 to December 5, 2022** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **₱25,000.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means;
