INVITATION TO BID

REHABILITATION OF IT INFRASTRUCTURE AND TELEPHONE LINES AT NEW ADMIN BUILDING AND POLICE STATION AT THE CAVITE ECONOMIC ZONE (CEZITB 2022-10-018)

1. The **PHILIPPINE ECONOMIC ZONE AUTHORITY-CAVITE ECONOMIC ZONE (PEZA-CEZ)**, through the **Corporate Operating Budget for CY 2022** intends to apply the sum of **Pesos: Five Million Three Hundred Thirty-Seven Thousand Three Hundred Sixteen and 23/100 Only (₱5,337,316.23)** being the Approved Budget for the Contract (ABC) to payments under the contract for Rehabilitation of IT Infrastructure and Telephone Lines at New Admin Building and Police Station at the Cavite Economic Zone. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PEZA-CEZ now invites bids for the above Procurement Project. Delivery of the Goods is required for a period of **one hundred twenty (120) calendar days**. Bidders should have completed, **within the last five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from CEZ-BAC Secretariat and inspect the Bidding Documents at the address given below during Monday to Friday from 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **05 October 2022** from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos Only (₱10,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

The PEZA-CEZ will hold a **Pre-Bid Conference¹ on 13 October 2022, 2:30 pm** at CEZ Function Room, 2F New Admin Bldg., CEZ, and/or through video conferencing or webcasting via Microsoft Teams, which shall be open to prospective bidders. The BAC Secretariat shall email the invite/meeting ID and password to those who signify their intent via email below.
7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address indicated below, on or before **25 October 2022, 2:00pm**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **25 October 2022, 2:30pm** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. In any case the above dates are declared a special non-working holiday, it will automatically be reset on the next working day
11. The PEZA-CEZ reserves the right to reject any and all bids, declare a failure of bidding, annul the bidding process or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
