  - It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.
- 5. The PEZA will hold a Pre-Bid Conference on 23 June 2016; 2:00 PM at the Conference Room, 2/f PEZA Administration Building, Mactan Economic Zone, Lapulapu City, which shall be open only to all interested parties who have purchased the Bidding Documents.
- 6. Bids must be delivered to the address below on or before 05 July 2016; 2:00 PM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
  - Bid opening shall be on 05 July 2016; 2:00 PM at the Conference Room, 2/f PEZA Administration Building, Mactan Economic Zone, Lapulapu City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
