1. The Philippine Economic Zone Authority-Baguio City Economic Zone (PEZA-BCEZ), now invites bids for the project:

2. Date of Submission of Bid documents	September 13, 2016 – 2:00 PM
3. Opening of Bids	September 13, 2016 – 2:30 PM
A complete set of Bidding documents may be purchased by interested bidders on July 23 – September 13, 2016 from the address below and upon payment of a non-refundable fee of Bidding Documents in the amount of Php 10,000.00.	

2. The delivery of the Goods and Completion of the Works are required within One Hundred Twenty (120) calendar days upon receipt of Notice to Proceed. *Bidders should have completed, within the last five (5) years from the date of submission and receipt of bids of a contract similar to the project at least 50% of the Approved Budget of the Contract.* The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instruction to Bidders (ITB).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnership or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from PEZA-BCEZ BAC Secretariat and inspect the Bidding Documents at the address given below from 8:00 a.m. to 4:30 p.m. only, Mondays to Fridays.
5. It may also be downloaded from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of PEZA-BCEZ, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.
6. The Pre-Bid Conference will be held at the PEZA-BCEZ Administration Building, 3<sup>rd</sup> Floor, Conference Room, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. In any case of the above dates is declared a special non-working holiday, it will automatically be reset on the next working day.
9. The PEZA-BCEZ reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
