Invitation to Bid for the Proposed Design and Build of Main Entrance Gate and Guardhouse at MEZ

PEZA MEZ 2021-015

1. The **Philippine Economic Zone Authority**, through the Corporate Operating Budget for the Year 2021 intends to apply the sum of **Eight Million Forty One Thousand Two Hundred Seventy Five and 47/100 (Php 8,041,275.47)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Proposed Design and Build of Main Entrance Gate and Guardhouse at MEZ. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Philippine Economic Zone Authority** now invites bids for the above Procurement Project. Contract Duration is one hundred (120) calendar days. Bidders should have completed a contract similar to the Project within three (3) years from the date of submission and receipt of bids. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **Philippine Economic Zone Authority** and inspect the Bidding Documents at the address given below from Mondays to Fridays, 8:00 am -5:00 pm.
5. A complete set of Bidding Documents may be acquired by interested bidders on **07 December 2021** from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php 10,000.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.
6. The **Philippine Economic Zone Authority** will hold a Pre-Bid Conference¹ on **15 December 2021; 2:00 pm** through videoconferencing, which shall be open to prospective bidders.


¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

7. Bids must be duly received by the BAC Secretariat manual submission at the office address as indicated below, on or before **27 December 2021; 2:00 pm**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **27 December 2021; 2:00 pm** at the DG's Conference Room, PEZA Administration Building, AAI Compound, Mactan Economic Zone, Lapu-lapu City, Cebu and/or through videoconferencing. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **Philippine Economic Zone Authority** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
