The bid opening for the **Procurement of Security Services Requirement of PEZA (PEZA-HO-2019-06)**, held at the PEZA Social Hall, 5th Floor PNOB Building 5, Energy Complex, Rizal Drive, Bonifacio Global City, Taguig, was called to order at 2:30 p.m. of 07 May 2019 and was presided by the BAC Vice Chairman.

1. The Vice Chairperson acknowledged the presence of the representatives of the bidders, BAC Secretariat, and the BAC Members. Observers that were invited failed to attend.
2. The Vice Chairperson informed that the bid opening was re-scheduled due to lack of quorum on the scheduled bid opening at 2:00PM of May 6, 2019, and bidders were properly notified of the re-scheduled date.
3. The Vice Chairman then announced the following:
  - a) The ABC amounts to ₱ 26,705,574.00. Bids exceeding the ABC shall automatically be rejected.
  - b) Three (3) bidders were able to submit their bid proposals before the 11:00 a.m of May 6, 2019 deadline.
  - c) Prices to be read are only the “Read-Out Prices” and are still subject to correction for mathematical/computational errors.
  - d) The BAC will only check the presence of the required documents using a non-discretionary “pass/fail” criterion. In case one or more of the required documents is missing, incomplete or patently insufficient, the BAC shall rate the bid concerned as “FAILED” and immediately return to the bidder its bid.

- e) Accepted bids will be subjected to detailed evaluation and post-qualification.
- f) The order of bid opening shall be as follows (based on time of submission):
- 3i International Security Services, Inc.
  - JANTRO Security Agency, Inc.
  - EliteBlue Security Specialist Inc.
4. The Envelope 1 (Eligibility Documents and Technical Proposal) of the bidders were opened and checked for compliance with the documents required to be submitted, as prescribed in the ITB and the BDS. The BAC ascertained that all documents required were present in the 1st bid envelopes of the bidders and their compliance were therefore rated as "PASSED/COMPLYING".
5. The BAC then opened Envelope 2 (Financial Proposal) of the bidders and checked for compliance with the documents required to be submitted for the second component of the bid, as prescribed in the ITB and the BDS. The BAC ascertained that all required documents were present in the 2nd bid envelope of the bidders and were therefore rated as "PASSED/COMPLYING".
