Latest Business Tax Return filed via eFPS *(Refers to the Value Added Tax (VAT) or Percentage tax returns covering the previous six (6) months. For those with less than six (6) months operations, this refers to the monthly business tax returns filed to date)*
- 3) Omnibus Sworn Statement (Notarized)
