RESOLUTION NO. 2022-06

WHEREAS, the Bids and Awards Committee conducted a public bidding for the “Procurement of Enterprise Video Surveillance System for CEZ, BCEZ, PEZ and MEZ, PEZA Command Center Components and Software Automation for Operations and Systems Integration of PEZA’s processes with the Development of the Electronic Letter of Authority (e-LOA) (PEZA-HO-2022-01)” with an **Approved Budget of Contract (ABC) of Three Hundred Twenty Nine Million Two Hundred Twenty-Two Thousand Five Hundred Forty-Two and 88/100 Pesos (PhP329,222,542.88)**;

WHEREAS, the said procurement is covered by PEZA Board Resolution No. 21-207 which approved additional priority CAPEX projects for PEZA in the amount of PhP331,000.000.00;

WHEREAS, the Invitation to Bid (ITB) of the said procurement was posted in the PEZA website, PHILGEPS and conspicuous place at the PEZA premises;

WHEREAS, on the deadline of submission bids on 20 December 2021, only one bidder, Annex Digital, Inc., (ADI) submitted its bid. However, the BAC, through its resolution No. 2022-01MR dated 21 January 2022, declared a failure of bidding as ADI failed to post-qualify;


WHEREAS, upon review of the terms, conditions, and specifications in the Bidding Documents, the BAC reduce the bidder’s qualification requirement from 20 years to 10 years (i.e., experience in the supply of goods and services in similar/related projects) to promote competition without compromising the quality of procurement;


WHEREAS, upon the conduct of re-bidding and re-advertisement, the bid of ADI, as the only bidder that submitted bid requirements and bid offer on 28 February 2022 at 11:00AM (deadline of submission) in the amount of **PhP329,000,000.00**, was subjected to eligibility check and was found to have met the eligibility requirements/criteria, and is considered as the Single Calculated Responsive Bid (SCRB) under Section 36 of 2016 Revised IRR of RA 9184;

NOW, THEREFORE, in view of the above premises, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED, to recommend to the HOPE the Award of Contract for the Procurement of Enterprise Video Surveillance System for CEZ, BCEZ, PEZ and MEZ, PEZA Command Center Components and Software Automation for Operations and Systems Integration of PEZA’s processes with the Development of the Electronic Letter of Authority (e-LOA) (PEZA-HO-2021-06) in the amount of **Three Hundred Twenty Nine Million Pesos only (PhP329,000,000.00)** to ANNEX DIGITAL, INC.


