

Terms of Reference

1. Preventive Maintenance covers ACUs located at the PEZA Field Offices with the following types and quantity:
 - a. Window-Type - 38
 - b. Split Type - 19

2. Quarterly Services
 - a. Dismantling and cleaning of ACU blowers
 - b. General cleaning of evaporators and condensing coils using pressure washer
 - c. Dismantling and cleaning of panels, surface covers, grills and air filters with soap and water
 - d. Flushing of drain lines
 - e. Re-assembly, re-alignment of ACU blowers, air filters, grills and panels' surface covers
 - f. Turn-on circuit breaker for test run and commissioning
 - g. Check fan motor supply line voltage and current draws
 - h. Check compressor supply line voltage and current draws
 - i. Check and record operating pressure (suctions and discharge) and temperature
 - j. Check for loose bolts, nuts, anchor and fastening of all electrical and electronic parts
 - k. Check for elimination of unnecessary noise and vibration
 - l. Check possible refrigerated leaks

3. Spot Service Report shall be submitted right after the scheduled service, countersigned by a PEZA representative. The general findings/evaluation report shall be submitted not later than three (3) working days after the quarterly services.

4. Other Requirements
 - a. Provision of at least two (2) on call resident technicians as may be necessary to do check-up and/or troubleshooting with free labor and with immediate response time of not later than 9:00 AM the following day
 - b. One (1) month warranty for services done

5. Exclusion
 - a. Labor and materials for system reprocessing and reconditioning works

- b. Cost of materials, spare parts for replacement such as compressor, fan motors filters, driers, expansion valves, thermostat switches, safety devices and other related components
- c. Repair in the leak system, recharging the unit with the required Freon Gas.
