SUBJECT MATTER: RECOMMENDATION FOR AWARD

PROJECT DESCRIPTION: PROCUREMENT THROUGH PUBLIC BIDDING OF THE PROJECT ENTITLED "PAINTING AND WATER PROOFING OF SFB NO. 1"

WHEREAS, Purchase Request (PR) No. BC-2018-12-07 was approved by the Procuring Entity for the public bidding of the project entitled, "**PAINTING AND WATER PROOFING OF SFB NO. 1**" with an Approved Budget of Contract (ABC) in the amount of Php3, 515,830.72;

WHEREAS, on 14 December 2018, the BCEZ - BAC has advertised an Invitation to Bid in the PEZA website, in the PhilGEPS and at conspicuous place at the premises of the PEZA-BCEZ;

WHEREAS, on 17 December 2018 during the Pre-Bid Conference, only Balbalin Engineering and Construction attended the activity;

WHEREAS, on 28 December 2018 during the Opening of Bids, ZHIKON BUILDERS and Balbalin Engineering and Construction submitted bid proposals, thereafter, the submitted bid document were publicly opened. The bid proposal of ZHIKON BUILDERS was adjudged the lowest calculated bid with a bid offer Php2, 999,921.82;

WHEREAS, upon evaluation of Technical Working Group of the submitted bid, an observation was raised to ZHIKON BUILDERS on the submitted Statement of All on Going Government & Private Contracts and Duly Signed Detailed Estimate;

WHEREAS, the BCEZ-BAC forwarded Letter of Clarification to ZHIKON BUILDERS based from the evaluation of the Technical Working Group;

WHEREAS, ZHIKON BUILDERS submitted Affidavit of Undertaking to comply with the observations of the Technical Working Group;

WHEREAS, on 23 January 2019, TWG found the contractor's bid proposal compliant;

WHEREAS, on January 03 - February 01, 2019, the BCEZ-BAC conducted post qualification evaluation of the Technical and Financial Components of the submitted bid documents, and the Post Qualification documents required from ZHIKON BUILDERS and found to be substantially complying and considered as the lowest calculated and responsive bidder;

NOW, THEREFORE, RESOLVED AS IT IS HEREBY RESOLVED:

1. To declare ZHIKON BUILDERS as the Lowest Calculated and Responsive Bidder for the "PAINTING AND WATER PROOFING OF SFB NO. 1"; and
2. For the Concurrent BCEZ OIC – Zone Administrator/Deputy Director General for Policy and Planning to approve the foregoing findings and award the contract to ZHIKON BUILDERS in the amount of Php2, 999,921.82.
