SUBJECT : Transhipment Service Allowance for PEZA Police Personnel
for Additional and Selected Points of Origin and Destination

DATE : 22 March 2010

Effective immediately, PEZA police personnel accompanying import and export shipments from ports of entry in Luzon and Mindanao to the economic zones or vice-versa shall be entitled to transhipment allowance for transhipment services rendered, as follows:
